

## Request for Proposal for Consulting Services

**POSITION:** Research & Data Cleaning Consultant I; Research & Data Cleaning Consultant II

**CONTRACTING ENTITY:** Helen Keller International

### **DURATION and TIMEFRAME**

Research & Data Cleaning Consultant I: Approximately 50 days of involvement is anticipated between November 2021 and November 2022.

Research & Data Cleaning Consultant II: Approximately 20 days of involvement is anticipated between December 2021 and February 2022.

### **BACKGROUND**

Helen Keller International’s Assessment and Research on Child Feeding (ARCH) Project works to improve infant and young child feeding policies, guidelines, and practices through the generation of country-specific evidence and technical expertise. The project’s overall aim is to generate evidence, build capacity, and improve policies related to marketing and consumption of commercial foods marketed for/consumed by infants and young children globally and in countries where evidence generation is supported – Cambodia, Indonesia, Nepal and Senegal. As one part of the project’s research portfolio, ARCH will generate evidence on the nutritional quality and composition of commercially produced complementary food products through nutrient profiling.

### **SCOPE of WORK**

ARCH will be assessing performance of 5,300 commercially produced complementary foods available through online retailers against national front-of-pack nutrition labelling schemes. ARCH is seeking two consultants to assist in the data cleaning and data management for this piece of research.

Under the supervision of the ARCH Senior Research Advisor, the research consultants will

1. Conduct a spot check in a dataset to verify nutritional composition information has been accurately pulled from the online retailer website.
2. Review website information of complementary food products to identify additional nutrient content and product preparation information.
3. Support write-up of results in a manuscript to be submitted for peer-review.

### **REQUIRED QUALIFICATIONS and EXPERIENCE**

- Master’s Degree in public health or nutrition

- Experience and knowledge of infant and young child feeding, experience with dietary assessment/nutrient analysis is a plus
- Computer literate and proficient with Microsoft Office products (Word; Excel; and PowerPoint)
- Knowledge and experience with statistical analysis and software (preferably Stata) is a plus
